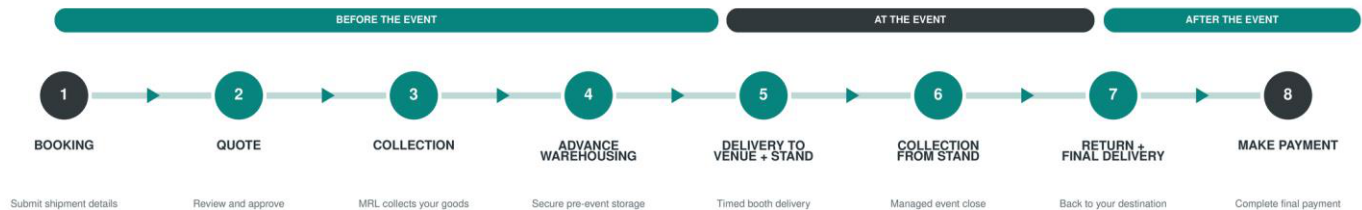

Restricted Destination Surcharge	GBP 35.00 per shipment	Countries subject to trade restrictions imposed by the UN Security Council
Address Correction	GBP 8.00 per shipment	Incorrect address at time of shipping or pickup causing delivery failure
Insurance	2% or GBP 20.00 minimum	Calculated using the declared shipment value
Adult Signature	GBP 6.50 per shipment	Delivery signature from an adult at the stipulated delivery address
Data Entry	GBP 4.50 per piece	When shipment data is entered manually on your behalf
On Hold	GBP 4.50 per piece	When a shipment cannot export for any reason
